

Media Library Lending Policy

a) Policy Statement

NUNAVUT TOURISM has invested in the creation of an audio/visual Media Library whose purpose is to provide material for the promotion of Nunavut attractions and tourism products. The Media Library is intended for the use of NUNAVUT TOURISM in its efforts to promote tourism opportunities and development in the Nunavut Territory.

b) For the purpose of this policy, the following definitions shall apply:

Media: Includes film-based images (positives and negatives), prints, digital images, video, film footage, audio, CD-ROM, graphics, illustrations, logos, articles, website content, and any other form of visual, audio or other media.

User: The individual, group, company, government department, association, or organization who submits a request for the use of audio/visual materials from the NUNAVUT TOURISM Media Library.

Project: The article, publication, story, advertisement, poster, display, illustration, video, film, website, or other media project proposed by the user.

c) Objectives

The objectives of this policy are:

- To ensure materials are made available for projects that will benefit tourism opportunities, awareness and/or development for Nunavut
- To provide guidelines for the conditions of use and the license agreement
- To maintain a collection of quality, high impact media for promotional and marketing activities

d) Scope

This policy applies to all users of the NUNAVUT TOURISM Media Library.

e) Procedures

1.0 Loaning Media

1.1 Criteria for Usage

In assessing requests, the following criteria will be used:

- Requested media is for non-commercial use only. This includes media, promotional, educational, and other non-profit purposes.
- User's project must demonstrate that materials provided by NUNAVUT TOURISM will be used to promote Nunavut and/or Nunavut products in a manner that will benefit tourism development in the territory.
- All User accounts with NUNAVUT TOURISM must be in good standing.

Non-commercial projects that do not demonstrate a positive benefit to tourism promotion, as decided at the sole discretion of NUNAVUT TOURISM, will be treated as commercial usage and charge applicable fees. See section 1.8 Commercial Usage for the fee schedule.

1.6 Unreturned or Damaged Media

Media must be carefully maintained and, except for Digital Images or CDs, returned at the User's expense. Upon receipt of loaned Media by the User or his agent (including any delivery service engaged by you) and until its return, the User shall be strictly liable as an insurer for its non-return or damage. In the event of any such loss, The User agrees to reimburse NUNAVUT TOURISM the following fair and reasonable values as liquidated damages: \$2,000 for each original Film-based Image; and \$200 for each duplicate Film-based Image.

Promotional CD ROM

Promotional CD ROMs, unless otherwise stated in the license agreement, do not need to be returned to NUNAVUT TOURISM.

1.7 Payment

All accounts are payable to NUNAVUT TOURISM within 30 days of the date of issue. Overdue accounts are charged an additional 5% interest per month on any outstanding balance. All Accounts are in CDN funds and may be paid by cash, cheque, or credit card (Visa, MasterCard, or Amex).

1.8 Commercial Usage

A special catalog within the Image bank will be created for commercial usage. Requests for media that have an intended commercial usage will be reviewed on an individual basis. Wherever possible, such requests will be referred to the source photographer, author, or creator of the media. Where the media is the sole copyright property of NUNAVUT TOURISM, a contract agreement with the User may be negotiated.

Media is not to be used for any products intended for re-sale without permission granted in writing from NUNAVUT TOURISM. This includes, but is not limited to:

- Packaging for software, music albums, CDs, cassettes and videotapes
- Book jackets and interior pages
- Calendars, books, guides, postcards, greeting cards and posters
